## **MOBILE MUSIC FESTIVAL TO TAKE PLACE ON SUNLINE BUSES!**

**(Thousand Palms, CA)** October 24, 2014 • On Saturday, November 01, 2014 some bus riders on the 111 bus line will be treated to live music from 27 local acts that are lined up to perform in the 111 Music Festival. Taking advantage of the intimate and unique atmosphere of SunLine buses to expose the Coachella Valley to music, culture and public transportation, the acts will perform from 2:55 pm to 7:05pm on several buses along the Line 111 bus route.

The mobile music festival is for all age groups and included in the SunLine Transit Agency normal bus fare that is as low as \$1.00 for a one-way ride and \$3.00 for all-day passes. The innovative music festival is a collaboration between SunLine Transit Agency and the Coachella Valley Art Scene. The goal is to promote bus ridership, raise awareness of the local transit system that is available to Coachella Valley residents and aims to educate the community on the positive benefits that public transportation offers.
